An Ordinance to erect a stop sign on Church Street at intersection of Church Street and Rodburn Place facing east and erect a stop sign on Church Street and Rodburn Ext facing west in the Town of Erin.

WHEREAS, the Town of Erin Town Board wishes to address safety concerns regarding the intersection of Church Street and Rodburn Ext, which were brought to the attention of the Town Board by area residents and the Town of Erin Highway Superintendent;

NOW THEREFORE BE IT RESOLVED, the Town of Erin Town Board hereby schedules a public hearing for June 11, 2025 at 6:00 p.m. at the Town of Erin at the Town of Erin Town Hall located at 1138 Breesport Road, Erin, N.Y. 14838 to receive public comment for the proposed Ordinance No. 2-2025, An Ordinance to erect a stop sign on Church Street at Intersection of Church Street and Rodburn Place east and to erect a stop sign on Church Street and Rodburn Ext facing west in the Town of Erin to wit:

An Ordinance to erect a stop sign on Church Street at intersection of Church Street and Rodburn Place and to erect a stop sign on Church Street and Rodburn Ext in the Town of Erin.

<u>Section 1</u>. Title. Ordinance No. 2-2025, An Ordinance to erect a stop sign on Church Street at intersection of Church Street and Rodburn Place facing east and to erect a stop sign on Church Street and Rodburn Ext facing west in the Town of Erin is to Code of the Town of Erin

<u>Section 2.</u> Intent. The purpose of this ordinance is to address safety concerns brought forth by residents and the Town of Erin Highway Superintendent regarding the intersection of Church Street and Rodburn Ext in the Town of Erin.

<u>Section 3.</u> Placement. The Town Board hereby enacted ordinance to authorize to erect a stop sign on Church Street and Rodburn Place, facing east for traffic traveling west and to erect a stop sign on Church Street and Rodburn Ext facing west for traffic traveling east in the Town of Erin.

<u>Section 4</u>. Inconsistent Ordinances. All Ordinances inconsistent with the above provisions of this Ordinance are hereby repealed.

<u>Section 5.</u> Severability. The invalidity or unenforceability of any section, subsection, paragraph, sentence, clause, provision, or phrase of the aforementioned sections, as declared by the valid judgment of any court of competent jurisdiction to be unconstitutional, shall not affect the validity or enforceability of any other section, subsection, paragraph, sentence, clause,

provision, or phrase, which shall remain in full force and effect.

<u>Section 6.</u> Authority. This ordinance is adopted in accordance with Town Law Section 64, 130, and NYS Vehicle and Traffic Law Section 1660.

Section 7. Effective Date. This Ordinance shall take effect immediately upon adoption and publication

according to law.
